# **VENUE: KELAB GOLF NEGARA SUBANG**

#### TERM OF THE COMPETITION

#### 1. **MANAGEMENT**

The Peugeot 48th Selangor Amateur Open 2023. Men & Ladies (hereinafter referred 1.1 to as the Championship) shall be managed by an Organizing Committee (hereinafter referred to as "The Tournament Committee") whose decisions in all matters relating to the Championship shall be final.

#### **VENUE AND DATE** 2.

2.1 The Championship will be played over the 54 holes at Kelab Golf Negara Subang (KGNS) on 28th - 30th November 2023 or any other course deemed fit by The Tournament Committee.

#### **SCHEDULE OF PLAY** 3.

- 3.1 The schedule of play shall be as follows:
- Practice Round 27<sup>th</sup> November 2023 (Monday) Registration & Official Practice Round
- Round 1, 28<sup>th</sup> November 2023 (Tuesday)

First Round (Men & Ladies)

• Round 2, 29th November 2023 (Wednesday) Second Round (Men & Ladies)

• Final Round, 30<sup>th</sup> November 2023 (Thursday) Final Round (Men & Ladies) and

Prize Presentation Lunch

#### **FORMAT OF PLAY** 4.

4.1 The tournament shall be decided by stroke play over 3 rounds of 18 holes each day, subject to The Tournament Committee's right in the event of circumstances that make the playing of 54 holes impracticable, to cancel any round or rounds at its discretion.

4.2 There shall be a cut-off after 36 holes of play. The <u>top 40% and ties for gross</u> and 20% and ties for net category leading players shall advance to the final round depending on the number of participants at the discretion of the Organizing Committee.

#### 5. **ELIGIBILITY**

- 5.1 The Tournament is open to male & female players who are:
  - (a) Amateur Golfers in accordance with the Rules of Amateur Status as approved by the R&A Rules Limited.
  - (b) Having a maximum World Handicap Index of **9.5 and below for Men** (Course Handicap 12 and below KGNS Putra Course) and **10.1 and below for Ladies** (Course Handicap 15 and below KGNS Putra Course) which must be current at the time of entry.
  - (c) Member of a Club affiliated with the Malaysian Golf Association (MGA) with similar handicap indices.
- 5.2 The Tournament Committee reserves the right to reject any entry without giving any reason. Players without a World Handicap Index issued by the MGA/NHS are not eligible to participate. Players from non-NHS Clubs may participate subject to The Tournament Committee's sole discretion.

(Please attach the payment slip together with the entry form upon submission with your name and mobile number written at the back of the slip). Those unable to register within the stipulated times may be accepted at the discretion of The Committee. **Entry forms without the accompanying payment will NOT be accepted.** 

Entry fee shall include green fee, twin sharing buggy, daily breakfast & lunch, goodie bag, and prize presentation lunch.

6.4 The field shall be limited to **120 competitors** on a first come first serve basis. In the event that entries fall short or exceed the number, The Tournament Committee reserves the right to make amendments to the entry requirements without giving any reason whatsoever.

#### 7. **WITHDRAWAL**

7.1 The entry fee will not be refunded if any competitors withdraw from the tournament and the withdrawal is made after **1700 hours (Malaysia Time)** on **7**<sup>th</sup> **November 2023 (Tuesday)** 

#### 8. **REGISTRATION**

8.1 All competitors are required to complete and submit the entry form and payment slip to <a href="mailto:selangoramateuropen@gmail.com">selangoramateuropen@gmail.com</a> by 1700 hours (Malaysia Time) on 7<sup>th</sup> November 2023. Failure to do so may result in the competitor being withdrawn from the Championship with no refund of any fees paid.

#### 9. **RULES OF PLAY**

9.1 Rules of play shall be in accordance with the Rules of Golf as approved by the R&A Rules Limited and the Local Rules of the Championship as approved by The Tournament Committee.

#### 10. **PRACTICE ROUND**

- 10.1 Official practice round is on **27<sup>th</sup> November 2023 (Monday)** from 7.30 am onwards. All players **must leave the golf course by 3.00 pm**. All players must inform the Tournament Secretariat and the club One-Stop-Center (OSC) for practice round booking at least 3 days prior to the event. booked through the Club 3 days prior to the event.
  - Green Fee is RM106.00 nett per player (18 Holes)
  - Buggy fee: **RM74.20 nett** on twin sharing basis
  - Caddie Fee: **RM74.20 nett** per caddie (18 holes)

#### 11. **DRAWS & STARTING TIMES**

- 11.1 Players shall be in groups of four/three (4/3) competitors at 10/9 minutes intervals.
- 11.2 The Tournament Committee will decide the draw and the starting time for the first two rounds. The draw for the final round will be arranged according to the first 2 rounds' scores; the lowest scores will tee off last from the first tee and the highest scores will tee off last from the tenth tee.
- 11.3 The draws and starting times shall be posted on the Tournament Notice Board. Such posting shall be considered sufficient notice for information and distribution.
- 11.4 The player shall start at the time laid down by the Tournament Committee. If a player arrives at his starting point ready to play within five minutes after his starting time, the penalty for failure to start on time shall be two strokes at the starting hole (Rule 5.3a). Otherwise, the penalty for breach of these rules shall be **DISQUALIFICATION.**

"Exception: Where the Committee determines that exceptional circumstances have prevented a player from starting on time, there is no penalty."

11.5 The Tournament Committee reserves the right to change the draws and vary the starting times without giving any reason thereof.

# 12. **PACE OF PLAY (Rule 5.6)**

#### **Time Allowed**

12.1 Each hole has been given a maximum completion time based on the length and difficulty of the hole. The maximum time allotted for the completion of 18 holes will be available prior to play.

#### **Definition of Out Of Position**

12.2 The first group and any group after a starter's gap will be considered to be "out of position" if, at any time during the round, the group's cumulative time exceeds the time allowed for the number of holes played. Any following group will be considered "out of position" if it is more than the starting time interval behind the group in front and has exceeded the time allowed for the number of holes played.

# **Procedure When Group Is Out Of Position**

- 12.3. If the decision is taken to time the group, each player in the group will be subject to individual timing by a Referee. Each player in the group will be advised that they are "out of position" and are being timed.
- 12.4 The maximum time allocated per shot is 40 seconds. 10 extra seconds are allowed for the first player to play:
  - A tee shot on a Par 3 Hole;
  - An approach Shot to the green; and
  - A chip or putt
- 12.5 The timing will start when a player has reached his ball, it is his turn to play and he is able to play without interference or distraction. On putting green, timing will start when the player has had a reasonable amount of time to lift, clean, and replace his ball, repair ball marks, and move loose impediments on his line of putt. Time spent looking at the line from beyond the hole and/ or behind the ball will count as time taken for the next stroke.
- 12.6 Timing ceases when a group is either back in position in relation to the preceding group or within the allocated time for the holes played.

#### **12.7 Bad Time**

- A player during Timing who, during a round records individual stroke timing that exceed the limit of maximum time allocated per stroke will be assessed a Bad Time.
- Bad times and the applications of penalties in the same round will be carried forwarduntil the Round is completed. A player will not be penalized if he has a second bad time before being advised of his earlier bad time.

#### **Informing Player of EST or Bad Time**

Except on the putting green, the Referee should advise that player as soon as
practicable that he has had a Bad Time. The Referee may ask the player if he is
familiar with the pace of play condition thereby ensuring that the player is aware
thata further Bad Time during the Tournament will result in a penalty of one stroke
beingapplied. If the Bad Time is on a putt or short chip, the player should be so
advised on the way to the next tee. A player will not be penalised if he has a second
Bad Timebefore being advised of his first.

#### PENALTY OF BREACH OF CONDITION

1 bad time The Player will be warned by the Rules Official and told that if

he has a further bad time he will be penalized.

**STROKEPLAY** 

2 bad times Penalty of one stroke

3 bad times Further penalty of two strokes

4 bad times Disqualification

12.8 If a group is "out of position" more than once during a round, the above procedure will apply on each occasion. Bad times and the applications of penalties in the same round will be carried forward until the Round is completed. A player will not be penaltized if he has a second bad time before being advised of his earlier bad time.

#### 13. **AUTHORIZED/UNAUTHORIZED TRANSPORTATION – CADDIE/ BUGGY**

- 13.1 Buggies are provided for all players on a twin-sharing basis. A buggy is part of the player's equipment. When a buggy is shared by two players, the buggy and everything in it are deemed to be the equipment of the player whose ball is involved except that when the buggy is being moved by one of the player's caddie, the buggy and everything in it is deemed to be the equipment of that player.
- 13.2 The players may engage a Caddies at their own arrangement throughout the Tournament.

#### 14. **APPROVED EQUIPMENT**

### 14.1 Golf Balls (Rule 4.2a)

Balls Allowed in Play of Round

(1) Conforming Ball Must Be Played. In making each stroke, a player must use a ball that conforms to the requirements in the Equipment Rules.

A player may get a conforming ball to play from anyone else, including another player on the course.

(2) Deliberately Altered Ball Must Not Be Played. A player must not make a stroke at a ball whose performance characteristics have been deliberately altered, such as by scuffing or heating the ball or by applying any substance (other than cleaning it).

#### 14.2 **Equipment (Rule 4.3a)**

#### Allowed and Prohibited Uses

A player may use equipment to help his or her play during a round, except that a player must not create a potential advantage by:

- 1) Using equipment (other than a club or a ball) that artificially eliminates or reduces the need for a skill or judgment that is essential to the challenge of the game, or
- 2) Using equipment (including a club or a ball) in an abnormal way in making a stroke. "Abnormal way" means a way that is fundamentally different than its intended use and is not normally recognized as part of playing the game.

This Rule does not affect the application of any other Rule that limits actions a player is allowed to take with a club, ball or other equipment (such as setting down a club or other object to help the player in lining up, see Rule 10.2b(3)).

### PENALTY: DISQUALIFICATION

#### 16. **SCORE CARDS**

- 16.1 All competitors must submit their respective scorecards duly signed and counter signed by his/her marker as soon as possible after the completion of each round and in any event, it shall not be later than **10 minutes** after the completion of each round.
- 16.2 A scorecard is deemed to be submitted the moment the competitor leaves the scoring area.

#### 17. **PRIZES**

# **Gross Champion**

17.1 The competitor who returns the lowest aggregate gross scores over 54 holes or less shall be declared "The Champion" and will be awarded the Championship Trophy.

#### **Net Champion**

- 17.2 The winner shall be the competitor who returns the lowest aggregate net scores over 54 holes or less.
- 17.3 Prizes will be awarded as follows:

#### **For Men**

1<sup>st</sup> to 10<sup>th</sup> placing gross scores over 54 holes or less

1<sup>st</sup> to 3<sup>rd</sup> placing net scores over 54 holes of less

#### **For Ladies**

1<sup>st</sup> to 5<sup>th</sup> placing gross scores over 54 holes or less

1<sup>st</sup> to 3<sup>rd</sup> placing net scores over 54 holes of less

NOTE: Number of prizes may be changed depending on the final entries.

#### 18 **SUSPENSION OF PLAY DUE TO A DANGEROUS SITUATION** - Rule 5.7 & Model Rule J-1

- 18.1 When play is suspended by the Committee for a dangerous situation, **all players muststop play at once and must not make another stroke** until the Committee has resume play. If a player fails to discontinue play immediately, he is **Disqualified**, unlesscircumstances warrant waiving the penalty.
- 18.2 The signal for suspending and resuming play is as follows.

Discontinue Play Immediately : **One prolonged note of siren.**Discontinue Play : Three consecutive notes of siren,

repeated.

Resume Play : Two short notes of siren, repeated.Penalty for Breach of Rule 5.7b : **Disqualification** 

When play has been suspended, players must ride on buggies to return to the Clubhouse for further announcements

#### 19. **COMPETITION CLOSED**

19.1 The Championship shall be deemed to have closed when the prizes have been awarded to the winners.

#### 20. **TIES**

- 20.1 In the event of a tie for the Gross category the first place, the winner shall be decided by a sudden death playoff on the hole to be decided by the Committee until the winner is decided by elimination. The purpose of the play-off is to decide the **WINNER** for the **gross** championship only.
- 20.2 In the event of a tie for any other places, the tie shall be decided by a count-back on the scorecard in the following order:

Last 18 holes. (Final Round)

Last 9 holes. (Hole 10 – 18)

Last 6 holes. (Hole 13 – 18)

Last 3 holes (Hole 16 – 18), and

Finally last hole (Hole 18).

If the tie is still undecided, it shall be decided by lot.

#### 21. **AMATEUR STATUS**

- 21.1 An amateur golfer must not accept a prize (other than a symbolic prize) or prize voucher of retail value in excess of USD1000 (RM4,000) or the equivalent, or such a lesser figure as may be decided by the Governing Body.
- 21.2 The limits prescribed in Rule 3.2a do not apply to a prize for a hole-in-one. An amateur golfer may accept a prize in excess of the limit set in Rule 3-2, including a cash prize for a hole-in-one made while playing a round of golf. Such a prize may be accepted in addition to any other prize won in the same competition.
- NOTE: The onus of receiving a prize or prizes that exceed the prescribed limits lies with the participant. The committee and its sponsors shall not be liable for any action on players for any breach of Rules pertaining to Amateur Status.

### 22. **DECISIONS**

- 22.1 If a referee has been appointed by the Tournament Committee, his/her decision shall be final. (Rule 20.2).
- 22.2 In the absence of a referee, any dispute or doubtful point on the Rules must be forwarded to The Tournament Committee, whose decisions shall be final (Rule 20.1c).

### 23. **DISPUTES AND APPEAL**

- 23.1 Any disputes that arise during the tournament must be put forward to the Appeal Committee as soon as practicable upon completion of a round and in any event, it shall not be later than <u>15 minutes</u> after completion of the said round.
- 23.2 A penalty of disqualification may in exceptional cases be waived, modified, or imposed by the Tournament Appeal Committee.

#### 24. **ETIQUETTE**

- 24.1 **CODE OF CONDUCT POLICY** Rule 1.2b
- 24.2 **Golf Attire**: All competitors are required to observe the KGNS Golf By-Law on Attire.
- 24.3 Tucked in Sport shirt with Turtle neck or with collar and sleeves, trousers/pants or skirt for ladies are allowed.
  - Jogging shorts, denim jeans, Bermuda beach shorts and football shorts are not allowed.
  - All players and caddies should practice good etiquette as in Rule 1.2a. The overriding principle is that consideration should be shown to others on the course at all times.

#### • Breach of Code of Conduct Local Rule

The following may be considered a "serious breach of etiquette" for this competition:

- Damaging Club property including putting green.
- Deliberately moving tee markers.
- Usage of mobile phones during a round to the annoyance and distractions of otherplayers. Exceptions: In cases of buggy breakdown or injury/illness.
- Deliberately distracting or offending other players while they are making strokes.
- Throwing a club towards another player or spectator.
- Using vulgar or offensive language.
- Consuming alcoholic drinks during play.
- Any other breaches not listed above but are deemed to be serious by the Committee.

Penalty For Breach This Local

Rule

First breach : Warning

Second breach : Disqualification

All players should practice good etiquette as detailed in Section 1 of the Rules of Golf. The overriding principle is that consideration should be shown to others on the course at all times.

# 25. **DRUGS**

25.1 Players must not make use of any type of drug to enhance performance. Should player show evidence of use of a drug for non-therapeutic purposes, the Tournament Committee may require the player to undergo a drug test. Any player infringing this condition may be disqualified. Players who are on medication and in doubt as to their clinical status should seek advice from The R&A via the Tournament Office

#### 26. **INDEMNITY/ LIABILITIES**

26.1 MGA, SGA, the Sponsors, The Tournament Committee, the Club, and their staff will not be responsible for any loss, damage or harm, or any form of injuries that the participants may suffer as a result of their participation in this tournament.
